Support for S.1, the For the People Act

"The For The People Act is important legislation that brings us another step closer to ensuring that every eligible Georgia voter can participate in our democracy. When we prioritize legislation that centers people and brings their concerns to the table, we have a better chance of getting it right. This comprehensive bill makes long-needed, pro-democracy reforms that would strengthen our democracy, and help ensure that our government remains by and for the people," said Senator Reverend Raphael Warnock.

"The *For the People Act* is an urgent and critically needed step to help make our democratic ideals a reality."

"As our country grapples with an unprecedented public health and economic crisis, it is urgent that Congress acts to end the culture of corruption that puts special interests ahead of the

American people," **said Senator Gillibrand**. "The *For the People Act* will root out corruption, increase transparency and accountability in government and protect and strengthen Americans' sacred right to vote. Given the attacks on our democracy and the challenges many Americans continue to face in order to exercise their right to vote, I am particularly proud that this legislation includes key voting rights provisions from the Voter Empowerment Act, a bill that I worked on with my friend, the late Congressman John Lewis. The *For the People Act* would restore American's faith in government and I urge all my colleagues from both sides of the aisle to support it."

"I am proud to join with Senator Merkley to co-sponsor the For the People Act, which would create clean and fair elections, end big money control of politics, and strengthen our ethics laws for federal employees. Among many important measures, this bill includes my legislation to crack down on the use of deceptive practices and voter intimidation efforts that are deliberately designed to suppress minorities' voting rights. We have seen a sustained pattern and practice of foreign governments and political campaigns trying to sow division and create fear in communities of color about exercising their sacred right to vote, and these tactics should be illegal," said Senator Cardin. "This measure also includes my Democracy Restoration Act (DRA), which would strengthen American communities by restoring voting rights to individuals when they have returned home after being released from incarceration. Voting is a fundamental right of citizenship, however, the United States is one of the few Western democracies that allows the permanent denial of voting rights for individuals with felony convictions. It's simply wrong that state disenfranchisement laws deny citizens participation in our democracy."

"The For the People Act is the most consequential reform proposal in a generation. It includes common-sense ideas that are broadly supported by the American people, from creating automatic and same-day voter registration to expanding options for early voting and vote by mail. We know these reforms work because they've worked in Colorado, where we have the second-highest turnout in America with 76 percent of eligible voters casting their ballots in the last election," said Senator Bennet. "I am especially pleased this bill reflects my proposals to ban partisan gerrymandering, close loopholes for lobbyists, and make it easier for college students to vote. By passing the For the People Act, we can fulfill our responsibility to hand our kids and grandkids a democracy in stronger shape than we found it."

"As big corporations continue to flood U.S. elections with dark money and Republicans in states around the country attempt to erect barriers to voting, we must act urgently to put our democracy firmly back in the hands of the American people. This legislation will do just that. I've been proud to work alongside my colleagues to author elements of this package and to ensure that this sweeping bill will strengthen our democracy and reduce the power of bigmoney special interests. The For the People Act is crucial to guaranteeing that America has free and fair elections, and the Senate must get it done," said Senator Van Hollen.

"As California's former chief elections officer, I was proud to help strengthen election security and boost voter turnout by implementing the critical reforms contained in the For the People

Act. They are proven, they are secure, and they should be available to all voters," **said Senator Padilla.** "Instead, we continue to witness an assault on American democracy based on lies and conspiracy theories. It has been two decades since Congress last took significant action to improve voter access and election administration--we cannot wait any longer. The fate of our democracy rests on our ability to protect voting rights for all citizens."
